RELEASE OF LIABILITY AND HOLD HARMLESS

I am the parent or legal guardian with responsibility for the minor child named below. I authorize my minor to participate in the Program provided by Pacific Science Center (PacSci) or its agents, on PacSci owned or leased property. I also give permission for my child to participate in short walking field trips off property during the camp day as part of the Program.

I acknowledge that I am the only one who can determine if my minor is capable of participating in the Program. I acknowledge the inherent risks that may result from my minor's participation in the Program including falls; fractures; cuts or scratches; contraction of infectious diseases; misbehavior of other participants; exposure to sun, insects, and other outdoor hazards; etc., all of which may result in injury or death to my minor or damage to their property.

I understand that attending the Program could increase the risk of contracting COVID-19 or another respiratory illness due to their contagious nature. I acknowledge that exposure to or infection with respiratory illness may result in personal illness, injury, permanent disability and death. I understand that infection with respiratory illness may result from the actions, omissions or negligence of myself or others, including, but not limited to PacSci employees and other Program participants and their families.

I voluntarily and expressly assume the risks and any associated costs, damages or losses, including those caused by simple negligence of Pacific Science Center, and waive and fully release all claims held by me, my spouse, my minor, or any of our estates from and against PacSci and its agency partners, officers, board members, agents, employees, volunteers, and representatives, arising from my minor's attendance and participation in the Program and accept full responsibility for the cost of all medical treatment to my minor as a result of any injuries caused by or through such risks. This waiver and release will apply to any and all actions, causes, damages, claims, or demands of every kind, whether known or unknown, arising out of or otherwise incidental to participation in the Program.

I further agree, on behalf of myself and/or my minor, to indemnify, defend, and hold harmless PacSci and its agency partners, officers, board members, agents, employees, volunteers, and representatives from any injuries, liabilities, claims, damages and expenses, including attorney fees, incurred by PacSci, me, my minor or on behalf of my minor, arising from my minor's attendance and participation in the Program, with the exception of gross negligence or reckless misconduct of PacSci.

While participating in the Program, I and my minor will obey all rules, regulations, and laws of the State of Washington and the United States. My minor and I will further obey all rules, regulations, and policies, those currently existing and those that are put in place during the Program, of PacSci associated with the Program. I acknowledge that my or my minor's failure to comply with these rules, regulations, policies, and laws may result in my minor's expulsion from the Program with no refund of costs.

I agree that this release will be governed by the laws of the State of Washington. If any provision herein is found to be invalid or unenforceable, then the remainder of this release will have full force and effect, and the invalid provision will be modified, or partially enforced, to the maximum extent permitted by Washington State law.

I have read all of the above terms and conditions, and I understand and agree to be bound by them.
